I then worked for two major law firms in Cincinnati, dealing predominately with complex civil cases. Opening my own law practice in 2002, I then had nearly 15 years of representing and advising individuals and small family businesses. Through my private law practice, I was involved in a variety of criminal and civil matters, including trials and appeals. Through this broad private practice of law, I better understand and appreciate the significant impact, both financially and emotionally, that being involved in any manner in the legal system has on both individuals and businesses. It is something I think about and appreciate in each case that comes before me to working to ensure a fair and timely resolution.

I want to continue to serve the people of Hamilton County in ensuring the predictability, stability and accountability provided by the law.
