**Martin H. Belsky**, Dean and Professor of Law, University of Akron School of Law  
Dean Belsky began his academic career in 1982 as Associate Professor of Law and director of the multi-disciplinary Center for Governmental Responsibility at the University of Florida. From 1986 to 1995, he served as Dean and President and Professor at Albany Law School. From 1995 to 2007, he served as Dean and Professor at the University of Tulsa College of Law. Dean Belsky joined The University of Akron School of Law in January 2008 as Dean and Randolph Baxter Professor of Law.



**Craig M. Boise**, Dean and Professor of Law, CSU, Cleveland-Marshall College of Law  
Dean Boise joined C|M|LAW from DePaul University College of Law, where he directed the Graduate Tax Law program from 2009 to 2011. He began his teaching career at Case Western Reserve University School of Law in 2003, and before that practiced corporate and international tax law for nearly nine years at Thompson Hine in Cleveland, and at Cleary Gottlieb, and Akin Gump, in New York. A graduate of the University of Chicago (J.D.) and New York University (LL.M) law schools, Dean Boise also served as a law clerk for the Honorable Pasco M. Bowman II, of the U.S. Court of Appeals for the Eighth Circuit.



**Lawrence E. Mitchell**, Dean and Professor, Case Western Reserve University School of Law  
Before joining the faculty at Case Western Reserve, Dean Mitchell was the Theodore Rinehart Professor of Business Law at The George Washington University Law School, where he taught for 20 years and was founding Chair and Executive Director of the Center for Law, Economics & Finance at GW. Professor Mitchell has written extensively on matters of corporate governance, law, finance, financial history, and ethics. A graduate of Williams College and Columbia University Law School, Professor Mitchell practiced corporate law in New York from 1981 to 1987.



**Daniel J. Steinbock**, Dean and Professor of Law, University of Toledo College of Law  
Dean Steinbock has been a member of the faculty since 1985 and has taught Criminal Procedure, Evidence, Administrative Law, Immigration Law, and Trial Practice. He was voted Outstanding Professor by six spring graduating classes. Prior to joining the College of Law, he taught at the State University of New York at Buffalo and Seattle University. Before entering law teaching he worked as a law clerk to U.S. District Judge Constance Baker Motley of the Southern District of New York, as a public defender with the Legal Aid Society in state and federal courts in New York City, and as Associate and Executive Director of Prisoners' Legal Services of New York.
