## **Bar Exam Review Course Fellowship Application**

#### **Summary:**

All January and May 2013 graduates taking a bar exam will be reimbursed 90% of the actual cost to them of a commercial bar review course, up to a maximum of \$2,200.

Bar Exam Review Course Fellowship checks will be processed for students <u>after</u> they complete the Exit Interview with Akron Law's Career Planning & Placement Office and comply with the other requirements, including submission of this form, receipt of bar review course final contract detailing actual costs to student, and signature approval by the Career Planning Office.

Batch fellowship check processing will begin October for January graduates and February or March for May graduates.

#### Fellowships will NOT be awarded IF the student:

- discontinued law studies (Transfer, Leave of Absence, Withdraw)
- is a non-Akron Law J.D. degree candidate students (transient, guest, audit, non-degree, etc.)
- does NOT register for a bar review course either at time of graduation or within 2 years following date
  of J.D. degree conferral
