Senate Chair Pastoria: We will now move onto the fun part, which is USG representative elections. President DeWitt if you would like to join me at the front.

President DeWitt: Okay? So, we've prepared a presentation for you all so you can learn a little bit more about these committees, because we'll be voting on them, and this is coming from just general USG membership, so anyone can be voted on these committees. So these are the voting ones.

• Faculty Senate Representative Election

President DeWitt: Okay, starting off with faculty senate. So this meeting occurs on Thursdays from 3:30 to 5:30. So, it does overlap with Senate a little bit, but I believe senators are free to be on this committee. It is the first Thursday every month, so its once a month. There will be two USG members that will serve as voting representatives on the Faculty Senate. One of them is automatically me as the USG president, and another one will have to be voted on so that can be any one from this body. Doesn't matter the branch.

Deputy Director Cosgrave: Could we just have a brief description of what this is?

President DeWitt: Yes, thank you. I was just going to follow up with that, so I appreciate it. So basically, I've had the opportunity to attend one of these meetings. Basically, what happens is, it's a big deal with faculty members. It's a formal setup kind of similar to Senate. So faculty will go through and give their reports the President often attends, other cabinet members, President Miller I mean, but yes, so I will be attending because I'm the USG President, whoever is the second representative will be as well. Basically, the role of USG during this time is just to sit and listen on the information that the faculty have to share. The Chair has to share and things like that. So yeah, and there will be a report at the end, but usually I'll be the one giving that. So that's

basically what happens at this meeting, just a formal setting, the faculty and other administration.

Senate Chair Pastoria: Anybody have a question? Seeing none. We will now move to nominations.

President DeWitt: Yes, I would like to nominate Vice President Kozma. Vice President, we

Vice President Kozma was elected to the second representative spot on the Faculty Senate.

• OSGA – Primary Delegate Election

President DeWitt: Okay, moving on now to OSGA, which

is also known as Ohio Student Government Association. So basically, the requirement for this that you must attend the OSGA conference if it is held. I believe that time changes every year. It's not like some set date that you have to commit to now, just keep that in mind. Two USG members serve as primary delegates, and those will be the voting members, and then there will be two USG secondary delegates, and they will be non-voting members, so we'll be breaking up that voting. You can see on the next slide, but the President will serve on OSGA automatically and be on the President's Council

and all the other three delegates, the other Primary delegate and the two secondary delegates will be voted from the USG general body.

All right, starting off with the primary delegate election. So this is kind of a reiteration of the last slide a little bit. So I'm already automatically a primary delegate as the president. However, there's someone else who needs to be voted onto that. So, that's what we are doing now, this other individual will be on here, and this, actually, I don't believe, was active this year, so it's going to be a new, defined role. I cannot tell you too much about it, but I do love it, it is basically, with other student governments in the area.

Senate Chair Pastoria: Any questions for President DeWitt? Seeing none, we will now move onto nominations.

President DeWitt: I would like to nominate Vice President Kozma.

Vice President Kozma is elected to be the second primary delegate for the OSGA.

• OSGA – Secondary Delegate Election

President DeWitt: Moving on to the secondary delegate election. Again, it's just a reiteration of that first slide on OSGA. So, this would be two members. They will be non-voting.

Senate Chair Pastoria: Any questions? Seeing none will we go into nominations.

Deputy Director Cosgrave: I would like to nominate Chief Justice Stillion. Director Gardner: I would like to nominate Chief of Staff Lane. Chief Justice Stillion: I would like to nominate Deputy Director Cosgrave. Senate Chair Pastoria: Are there any other nominations. Seeing none, we will now move on. Senator Feezel: Motion to close nominations and take to a ballot. Senator Cameron: Second. Deputy Chief of Staff Machar: Point of order, there should be an opportunity to speak on the nominees, if necessary, where the nominees do exit the room, and then we would take this to a vote on the ballot. Senate Chair Pastoria: Yes, would the nominators like to speak on behalf of the nominee? Director Gardner: So I nominate Chief of Staff Lane, because, as we've seen the past two years, they're very involved in Ohio Student Government Summit, so it might be easier for them to coordinate with other student governments and take feedback, if they were on a committee and could hear their feedback throughout, while also planning.

Senate Chair Pastoria: Would anybody else like to speak on the behalf of their

nominations?

Deputy Director Cosgrave: Hi there. I nominated Chief Justice Stillion for this position. I believe that Chief Justice Stillion is in a very unique position, and would serve very well on this board. So OSGA is the Ohio Student Government Association. That role really hasn't been well defined, but it's basically whenever student governments from across the entirety of Ohio come together to meet, to collaborate on ideas. Not only do I think that this should be someone who is experienced in undergraduate student government, which Chief Justice Stillion has, I believe that it should also be a person who has experienced leadership within the organization so they truly understand it within and without of the organization. But I also believe that Chief Justice Stillion would bring a unique perspective to this, because many of you don't know this, but most of the other student governments within the state do not have a judicial branch, and I believe that our specific undergraduate student government brings a very unique perspective on that. So I believe that having the Chief Justice, specifically Chief Justice Stillion, in this case, on that committee, would bring a unique perspective, not only from the

University of Akron, but specifically from our judicial branch, that I think would be very beneficial with the upstart of this committee.

Senate Chair Pastoria: Thank you. Chief Justice Stillion?

Chief Justice Stillion: I nominated Deputy Director Cosgrave because this would be their fourth year in USG. They have served as a senator and as Senate chair. They have a very unique perspective on how the organization functions, a very in depth understanding of what we as an undergraduate student government do. I think that is very important to bring to the table for something like the Ohio Student Government Association, where we're going to be able to share our ideas and how we function

uniquely in ways that other organizations do not.

Senate Chair Pastoria: We will now move onto the voting.

Deputy Director Cosgrave and Chief Justice Stillion are voted into the secondary delegate positions.

President DeWitt: All right, this is our last voting committee. So, University Council, I had the chance of being on the committee in the last year, and I can say a little bit about my experience. Basically, you attend meetings on a Tuesday from 3:00 to 4:30, the second Tuesday of each month, so only monthly meeting as well. So, it is kind of in the middle of the day but if you are available, this is an option for you. Basically, what happens is a lot of different staff and administration will come here.

They'll give reports for different committees that they are a part of. President Miller sometimes attends, Dr. Messina, people like that. So it's again, just like, kind of a similar meeting faculty senate. But it's not happening based so that's the University Council. There are student representatives on it. There are three who serve as voting. Voting members, one will automatically be the USG President, so I will be on it already, but there will be two positions that will be elected from this body. And again, it can be

any branch, anybody that's a member.

Senate Chair Pastoria: Any questions about that? Seeing none we will move onto the nominations.

President DeWitt: I would like to nominate Vice President Kozma.

Senate Chair Pastoria: Any other nominees?

President DeWitt: I would like to nominate Senate Chair Pastoria.

Senator Feezel: Motion to close nominations and to suspend the bylaws and use a vocal vote.

Senator Rahman: Second.

Vice President Kozma and Senate Chair Pastoria are elected to the two remaining student spots on the University Council.

• University Council Committee Placements

President DeWitt

President DeWitt: These are non-voting committees and are not nearly as

long as the voting committee. So, university council committees. This is kind of confusing. So it's University Council is what we just went over. And these are, these are committees within University Council. Does that make sense? Perfect. So here are the options. We have the opportunity to have two students on each however, I will say we would like for the Director of Finance on Budget and Financing. We're probably only going to, you know, ask for interest for one position at this time until

we fill the Director of Finance. So I'm just going to ask, is anyone interested in on Institutional Advancement. Okay, moving onto Student Engagement and Sucess. Anyone interested?

Senate Chair Pastoria: I can just say that I served on this UC committee in the fall semester. Its a really cool committee, you do a lot of interesting projects, you work with Dr. Messina, and overall I had a good time.

President DeWitt:

Moving on to the budget and finance. Is there an individual that's interested in

this? Oh. Love the engagement. All right, moving onto Campus Involvement. Communications? Okay, Talent Development and Resources. Physical Environment committee?

Director Gardner: What's your question? Okay, so physical Environment Committee, I was on it as the facilities, amenities, services and transportation committee chair this whole year. It really focuses on what's going on on campus and what will shut down, and how they're combating what's going on. For example, one of the big topics that they talk about is exchange. We hear that at least once

every single meeting that we have, it's usually, it's always once a month for, I think an hour and a half, and they talk about sort of requests, if someone wants to, like, switch offices, or if an elevator is broken, they'll talk about that and how to fix it. And you can give student input of when they're like, "Well, I don't know how much this is going to affect everyone's day." There was a project, and it definitely affected students who were disabled in how they would get about classes. So I made sure to bring that up and say that if they were to do this project, they would have to come up with an alternative way for them to get around the construction build up.

President DeWitt: Moving on to the last one, Information Technology. How about some new people.

Senate Chair Pastoria: I was also on this one. If you are interested in AI or like, doing some tech on campus. They're very excited about students, but especially with new ideas. So anybody interested in that.

President DeWitt: That concludes this then, thank you guys. I was not expecting that engagement, so you're trying to do that. You're ready to be involved.
