Associate Justice Shaw: Hi Guys! You may have seen my message in the Off-Topic channel in the Teams, but I just wanted to echo it here. For those of you who don't know, I am also the Secretary of Honors Civics Club and my job is to reach out to different student organizations and promote our meetings. So our next meeting is a pretty big one, we have one on Monday the 24th, which is this upcoming Monday, from 4:45-6:00 pm in the Honors Common Room. This meeting we are discussing Ohio Senate Bill 1 and we will have Ohio Senator Cirino, the writer of the bill, in attendance as a special guest. So I encourage all of you to promote your first amendment right of free speech and come out to our meeting. We will have food, we will have drinks and snacks, courtesy of College Republicans. If you are interested in attending this meeting, registration is required since Senator Cirino is an elected official, so that form can be found in my post in the Off-Topic channel. It'll ask if you want to register under a student organization, you can or can't, it doesn't matter, as long as you register you can submit questions on there and that form closes Sunday the 23rd, so if you are looking to come to that meeting on Monday, make sure to register. VII. Branch Reports

∠ Legislative Branch Report Senate Chair Feezel

Senate Chair Feezel: Moving onto Branch Reports, starting with the Legislative Branch Report.

Make sure you are filling out your Project Trackers with anything that you worked on this week. We are going to be scheduling those Check-Ins next week, so you will be receiving an email from Ali or myself about scheduling those. Assuming one of us is available during your office hours, you'll probably just receive an email from us saying that we'll show up at the time. If not we'll try and find a different time, and we'll try to make it as convenient as possible for you guys.

On March 6th, I believe that is a Thursday, is an All-USG meeting. We rescheduled the Provost and possibly the Senior Vice Provost to come to that meeting as a guest speaker, so that All-USG is able to attend, hear about it, and provide insight. So please submit any questions or discussion topics you have to that form. Again, the goal is that we have him talking about the retrenchment and budget process. There's a lot of questions that students have brought up about it, about how it's going to effect their programs, and how it's going to effect their friend's programs. You guys have probably heard something about it, and how it's going to affect student amenities as well, so make sure you are thinking critically about how it's going to affect you, how it's going to affect your constituents, and then bring that to your discussion on March 6th and submit questions to the form, so that the Provost has time to prepare. As we've seen multiple times at Faculty Senate, he usually has a partial answer to most of the questions, but it's usually often defer and say that he doesn't know exactly and that he'll get back to you on that. So submit your questions before hand, so he can prepare his responses and get your questions fully answered during the meeting. Yeah that was a lot of yapping, but hopefully you understand the importance of submitting beforehand. I won't be removing any questions, unless they are unrelated, and you can ask follow up questions on the floor as well.

In discussion today, we are going to be briefly checking in on legislations planning and progress. A lot of you are working on legislation and a lot of you are interested in working on legislation. So, we just want to make sure that everyone is working on something and not working on the same thing as someone else. I know some Senators are missing, so it might be difficult, but we're just going to do a brief check-

in.
