VII. Branch Reports

∉ Judicial Branch Report

Chief Justice Stillion

Senate Chair Feezel: Moving onto Branch Reports starting with the Judicial Branch Report given by Chief Justice Stillion.

Chief Justice Stillion: They've got me up here too much today guys, three reports that's

crazy. We were very busy this week. We took a little bit of a detour from our normally regularly scheduled Judicial Branch work. We have had two different grievances, one constitutional and one elections grievance. So at our meeting on Monday, we heard the constitutional grievance and voted to hear it, 4-1 in favor of a constitutional violation occurring. At that meeting as well we voted to hear the election grievance, and that is happening right now. A special judicial branch meeting, in the USG office with some of our other members are hearing that grievance right now and we'll hopefully vote on it before the end of the night. So that was fun, that's something that doesn't happen often. We were supposed to meet with the Department of Student Conduct this week, but that meeting was cancelled and moved to the end of March, but we didn't have too many action items for them anyways. We are still just moving forward with helping them with programming. As always, well I don't want to say that thats not good, as has been for the past couple of weeks, the Associate Justice application is open. We have one open position, so if you know anyone who's interested point them in that direction. Are there any questions about the Judicial Branch Report?

President DeWitt: Moving forward, can they hear more about the constitutional grievance at a meeting?

Chief Justice Stillion: I don't think so.

President DeWitt: Can they, is DLT in executive session then?

Chief Justice Stillion: Yes. Part of the dispute resolution process is that all information we receive in regard to any grievances is kept confidential. That process is going to be reviewed in the next few weeks following our hearing of the elections grievance so that may be changed it may be presented to you for review. We're not totally sure how we want to move forward with this dispute resolution process. It hasn't been updated since 2021, so it's definitely not the most updated document, so we will be looking at it. As it stands now, all information we receive has to remain confidential. Any other questions regarding that? Onto the meme.

∉ DLT Report

Chief Justice Stillion: Moving onto the DLT Report given by Chief Justice Stillion.

Senate Chair Feezel: Um yeah, moving onto the DLT Report given by Chief Justice Stillion.

Chief Justice Stillion: We also had a pretty busy meeting this week in DLT. The End of Year Award form is open, it's going to be open for the next two weeks, so make sure to

look at that. These are pretty exciting awards, everyone that gets one gets a real plaque with their name on it, it's pretty cool. They close on March 10th, since these are sometimes more competitive and a little bit more higher level, we are asking for a half to a whole page for a nomination. So that when we get in there, write about what you've seen people do this year, accomplishments that they have done, you can write about yourself if you'd like, but definitely go in there, be comprehensive, lift people up with what they've been doing this year in your nominations! Those close March 10th. It says RSVP to USG Awards Gala, that's already closed, so if you didn't do it already its too late. If you didn't and you're like I don't know how I missed this. Reach out to DLT and maybe we'll be able to move some things around, but I believe the catering has already been ordered so we can not take like five more people, but maybe if there's just one we could fit it in somewhere.

President DeWitt: You can literally let me know right after this if you forgot, I can squeeze you in. Please just let me know.

Chief Justice Stillion: In the more specifics of what we worked on, we recapped Vice Week and the All-USG retreat. Talked a little bit about those, the things we enjoyed, the things we want to do a little differently. Especially during Vice Week many of our members of DLT were sick so we were not able to complete that to it's fullest capacity. We also reviewed the time lines for the LIFE Awards. We will all of those compiled for us and given to us to review those for the next senate meeting to discuss and make our decisions on those. We did take a fairly large chunk of that meeting to work on our own living transition documents. Which most of ours now are 20+ pages of transitions that will be going to the next administration. Just a reminder to CC your branch heads and President DeWitt, Vice President Kozma, and Advisor Alexander on all emails to the organizations. We want to be aware of what you are all doing, so that we can talk about it to administration or if someone reaches out to us and says I have never heard of this project, that would be awkward for us. So, make sure to CC the correct people on those. As always are meetings are on Mondays from 6:30-7:45pm. We are right on the other side of that wall. We have visiters all the time, it's a great time and feel free to visits. Any questions about the DLT Report?

∉ Legislative Branch Report

Vice Senate Chair Winters

Senate Chair Feezel: Thank you Chief Justice Stillion. Moving onto the Legislative Branch Report given by Vice Senate Chair Winters.

Vice Senate Chair Winters: Okay! So, the Legislative Branch, it's a pretty standard agenda for us this week. Project Trackers, we're currently trying to schedule Check-Ins.

We have already gone ahead and looked at all of your office hours, when Cam and I can come in and talk with you guys, specifically about them, and just kind of do a little 2:1. Make sure everybody's on the right track and everything, and make sure everybody is doing them properly. So here is the questions form for the Provost. He comes next week at the All-USG meeting. Is Dr. Price coming, do we have an update?

Senate Chair Feezel: It was unclear.

Vice Senate Chair Winters: Unclear, okay! Potentially Dr. Price as well, so that's for that meeting. Again, those are our vacancies: Senator At-Large, Senator for the College of Health and Human Sciences, Senator for the Williams Honors College, Senator for the College of Business, and the Senate Clerk. We did have two interviews today, very exciting so hopefully some of those will be gone.

Senate Chair Feezel: And if you know anyone who wants to apply, tell them to apply quickly.

Vice Senate Chair Winters: Yeah! Apply quickly if they want to! Okay, Provost questions. Everybody get your phone out and everybody is going to write one question for the Provost next week.

Senate Chair Feezel: There was a lot of discussion about the budget cut process when it got brought up, so I expect more than zero responses here, so everyone submit one question. I'm sure you've heard at least one part of the discussion about it.

President DeWitt: For the people who don't know, what does the Provost do? Why are we having him speak?

Senate Chair Feezel: So, the Provost is the head of the Office of Academic Affairs. He, in like the hierarchy of higher education, it goes your Professors, Department Head, Department Chairs, Deans, and then the Provost is the top of that, right next/below the President. So, he is pretty much the highest point of Academic Affairs in the institution. So he handles all that stuff and including the budget cut process, especially when it comes to academic programs that have been cut and like the budgets for individual departments. All of that is pretty much covered by him. He has a really heavy hand in playing the Board of Trustees retrenchment process, I think he's developing a proposal for the budget cuts currently being presented. So he'll be able to talk about that, he'll be able to talk about how that will affect students, how many programs will be cut, how many students are graduating from those programs, how he made those decisions. So all of that stuff is kind of what we're looking for from him.

Vice Senate Chair Winters: He's also resigning from the Provost position at the end of May, like as soon as graduation is over, and he is moving back to a faculty position so that's interesting. But, yeah I'm sure you guys have heard that, we've talked about it for a couple weeks. Any questions about the Provost meeting specifically, what to expect next week? He is going to have an unlimited amount of time to talk, since it will be an All-USG meeting, so we're not going to keep him on that 15 minute time crunch that we typically keep speakers on. So, ask as many questions as you want to. I think we're going to open the floor at some point too.

Senate Chair Feezel: So yeah, these are just going to be compiled into general areas of discussion topics for him, so that he has a chance to prepare and have proper answers to them. But you will also be welcome to ask questions or follow-up questions on the floor, just make sure that you are being professional and respectful in every question that you ask. Address him formally, address the question as it relates to the student body, your constituents, try and keep as much personal drama out of it, so this is a productive dicsussion about how you can best represent your constituents. Any questions?

Vice Senate Chair Winters: Yeah if there's no questions about the Provost, is there any questions about LB at all maybe? Okay, thanks guys!

∉ Executive Branch Report

President DeWitt

Senate Chair Feezel: Moving onto the Executive Branch Report given by President DeWitt.

President DeWitt: Your favorite report of all time in the whole wide world. A lot of words on this page, but basically EB committees, I wanted to talk about this. If you don't remember, EB has three committees open to all students, so any branch can be apart of it. It's Campus Dining Experience, Mental Health Task Force, and then Diversity Committee. They all have biweekly meetings, just an hour or less, they have fun events some times, it's just a great time. So, if you're interested in being a part of any of those committees, they are currently recruiting for more people, so let me know or it should be in the All-USG calendar if you want to just take a look for the times on there and show up. So remember three weeks, three weeks! They are going to deny your request if it is unreasonable. So like if it's the week of, we unfortunately can not accommodate that. So, please be respectful of our teams and their timelines for that. We can move onto Events and Meetings this week. Basically, BEC and USG had a spirit week this week. A lot of cool things happened, the only thing remaining is our Slam Dunk with Zippy event on Friday from 3:00-5:00pm in the International Lounge. ∉ Elections Board Report
